Recently Asked Questions and Answers



Q—Does a Commander only vote to break a tie?

A—No. As a member of this organization, the Commander has the right to cast their vote on any issue.

Q—Our Unit wants to conduct a fund raiser. What should we do?

A—We strongly suggest that you refer to Article XV, Section 3 and 4 of the DAV Auxiliary national bylaws. Once the unit body votes to hold a fundraiser, it is recommended that written request for parent chapter permission be delivered to the Chapter for consideration and approval. Said approval should be in written form. Where no commissions are to be paid, no prior approval shall be required from the DAV Department Executive Committee when the gross receipts will be less than \$5,000. However, advance notice of such fund raising activity shall be furnished to the DAV State Department not less than 30 days prior to the fundraising event.

Q—What is considered a "membership year?"

A—Our membership year runs from July 1 through June 30.

Q—Can any member attend a state or national convention?

A—Yes. However, if you want to have a voice and/or vote on the convention floor, you must be a member of a chartered unit in good standing with your dues paid and be elected as delegate.

Forget-Me-Not Drive Clarifications

In accordance with DAV national bylaws, units may conduct one Forget-Me-Not Drive annually with its chapter's prior consent. Additionally, auxiliary units are to advise the DAV state department in advance of the annual drive. DAV bylaws state: "Each annual Forget-Me-Not Drive shall not exceed seven consecutive days, without the consent of the state department."

If the unit decides to explore the possibility of splitting up the collection days to equal the seven maximum days allowed, this would require DAV state department approval as stated in the bylaw quote above. Collection location changes would also require approval to make sure there is no overlapping of other DAV chapter/unit territories or any other conflicts.

Unfortunately, if the donations collected are not as anticipated due to weather, location, or other circumstances, there is nothing that can be done about that. In those cases, the unit will have to think of other fund raising ventures to meet specific project needs.

We recently returned home from the annual National Advisory Committee meetings for the VA Voluntary Service Program in Cary, North Carolina. It was a great week of learning and sharing ideas, but one theme stuck during the entire conference. That theme is the importance of recruiting new volunteers.

Did you know the average age of a volunteer is 70-80 years old? The younger generation of volunteers aren't being encouraged or invited to volunteer, when in reality there is a great deal of opportunities available for them. Whether a person can volunteer once a week or once a month, VAVS Representatives and Deputies must work hard to encourage and support volunteers. Without them, our Veterans will not get the services that they need and deserve.

Another great aspect discussed was the monetary value of volunteers to the VA Health System. Volunteer hours equal over \$100,000 worth of service, which means more money can be used for Veterans and less on additional staffing. Furthermore, the net worth of volunteers is an average of \$22.17 per hour. Imagine the difference we're making for Veterans by taking the opportunities to serve!

We encourage all representatives and deputies to reach out to their communities, beyond local units and chapters, and encourage volunteerism by all ages and all walks of life. Recruitment doesn't end when that volunteer starts, but rather continues during their entire service time within the VA Health System. Reward, congratulate and encourage volunteers, and they'll be around for many years to come.
