Don't forget that the down payment for a life membership is only \$20.00! Members are billed quarterly and have at least three years to pay. If the membership is not paid in full at the end of three membership years, the member shall continue only as long as there are sufficient funds to make the annual distribution. This plan essentially extends the payment time beyond the three-full-membership year requirement so long as the member pays enough on their life membership each year to make the July 1 membership distribution. Remember that dues paid on an annual membership may not be applied toward a life membership.

Thank you to all of our members who continue to contact their respective Senators and Congressmen.

Another aspect of legislation is the U.S. flag and the fact that it has always represented American Pride. Let the inspiration of the flag and what it represents be displayed as a symbol to demand this country's leadership accomplish the following:

- 1. Fix the veterans' system so U.S. military soldiers and veterans receive the best medical care.
- 2. Stop wasteful spending and work under a balanced budget so hard-working taxpayers receive the ultimate value of each tax dollar.
- 3. Secure our borders for the safety of this great country and for all illegals that have been used and abused in their quest for the American dream.

We as citizens are not interested in the political drama so prevalent in this government. We want honest and sincere leadership working together for a better America. ### Community Service by Ellen Timmerman, Community Service Chairman

By the time you read this all of the "State Conventions" will be over and all of your reports will have been judged. The winning reports have been mailed to National Headquarters to be judged again during the National Convention in Las Vegas. No matter how your report is judged, you are all winners; the fact that you've given your time to help just one person in your community makes you a winner.

We've already started a new year helping in our communities, and even though we don't do it to be patted on the back, it's still nice to receive some kind of acknowledgement of what we have accomplished. We can't do that if your unit doesn't turn in reports. Thirty (30) states turned in reports with a total 556,875.6 in hours, 1,068,674 miles driven and \$2,849,089.70 in items and money donated to your communities. Can you imagine how high these totals would be if every unit did reports? Next year, let's try to increase the number of states participating; in fact, it would be great if every state turned in reports.

"Community Service is involvement. It is knowing, caring and participating in our surrounding environment. It is being aware of life, and all the responsibilities it holds." (Auxiliary Manual) Community Service is doing something that helps another person that is not a family member. It is expected that we will help family because they are family.

#### **Indebted Units**

Units and state departments that have not paid their national mandates nor submitted an annual financial report are considered INDEBTED.

Units and delegates must ensure that 2013-2014 national mandates are paid and a financial report is on file with national headquarters by July 31, 2014. Failure to comply will result in elected delegates not being permitted to register in the capacity of convention delegates at the national convention.

A member of an indebted unit may attend convention business meetings and functions as a registered member/guest without voice or vote.

Elected national convention delegates are entitled to the privilege of representing their unit/state department so please see that all indebtedness is satisfied prior to the national convention.

# Understanding the tax-exempt revocation procedure

It is important for all units and state departments to ensure they are submitting a 990-N e-Postcard yearly. Failure to file for three consecutive years will result in the loss of the tax-exempt status, and results in a monetary fine by the IRS. Do not lose your tax-exempt status. If you're struggling, please contact National Headquarters, and we will be happy to assist you. Documents are available for those who need guidance with setting up an e-Postcard account or filing.

To ensure that units are given ample time to correct their tax-exempt problem, should one arise, the following procedure will be used for units who have lost their tax-exempt status:

- ⇒ Every month, DAVA National Staff will check the IRS website for any units whose tax-exempt status was revoked since the previous month. That unit will immediately go on hold and a letter will be sent advising of loss of exemption and steps to regain tax-exemption and get back into good standing. What we will request is a copy of the first page of IRS form 1024 and a copy of the \$400 check. The unit has 60 days from the date of the letter to respond.
- ⇒ If no response, a 2nd notice will be sent advising that the charter is in danger of being suspended unless the information is received within 60 days from the date of the 2nd letter.
- ⇒ If no response to the 2nd notice and no attempted contact has been made by the unit to national headquarters, the charter is temporarily revoked until the paperwork is received or 18 months has passed, whichever is sooner. If we have had no contact or resolve after 18 months, the charter is revoked.
- ⇒ If, after the 2nd letter, the unit has contacted headquarters but still has not submitted the proper paperwork, the unit will be placed on a suspension for 180 days. If the information is not received within the 180 day period, the charter will be temporarily revoked for 18 months or until the paperwork is received, whichever is sooner.

Please note: The DAV Auxiliary National Headquarters office will be closed August 4-8, 2014, for National Convention.

LeeAnn Karg, National Senior Vice Commander, and her husband, Van, recently received the "Service Above Self" award from the Hutchinson Rotary Club. This award, received "in recognition of their many years of service to our community. epitomizing the rotary motto service above self," is only the second of its kind to be presented by the Hutchinson Rotary Club. 
