National Bylaw Amendments Approved at National Convention

- Effective <u>July 1, 2015</u>, annual membership will be eliminated. The changeover to life membership will have no effect on those who wish to continue paying dues annually since the life membership payment plan is structured to allow for a nearly unlimited length of time to complete payment. Beginning early 2015, current annual members will be invited to convert to life membership. More information will be available at that time.
- ◆ Effective <u>July 1, 2015</u>, junior membership will be complimentary until age 18. Included will be the option of starting a junior life membership for \$250, with the same payment plan mentioned above. Junior life members will have unlimited time to pay as long as there is enough for life distributions July of each year, and distributions will not begin until the month they turn 18. Beginning early 2015, current junior members will be invited to convert to life membership. More information will be available at that time.
- Effective <u>immediately</u>, the number of members present for a quorum will go from 5 members to 4 members. One member present shall be the Unit Commander or a Unit Vice Commander.

There will be other changes posted in future Headquarters News publications. The availability of updated **Constitution and Bylaw** books will be announced in a future edition of the Headquarters News and other social media venues.

She was a regularly-scheduled volunteer at the VA Outpatient Clinic in Cape Coral, Florida, compiling nearly 2,000 volunteer hours, and recently completed a two-year term as Deputy VAVS Representative at that facility. Kay held many elected and appointed positions in Florida's DAVA state department and days before her passing ended her second state commander term at their state convention.

Aside from her long-standing dedication and legislative advocacy seeking support benefitting veterans and their families, Kay held a degree in Clinical Psychology, acquired Master Gardener accreditation, and was actively involved in the Red Hat Society of Lehigh Acres, Florida. She retired from the Lee County Sheriff's Department as a desk officer.


