# William Craig Johniken Elected National Commander

William Craig Johniken was elected National Commander of the DAV Auxiliary at the 2017 National Convention in New Orleans, Louisiana. Craig is the first male to serve in this capacity since the inception of the organization in 1922.

Mr. Johniken is eligible for membership through his wife, Teresa, a service-connected disabled veteran and DAV member since 1995, and his son, Tim, also a service-connected veteran.

A native of Texas, Craig began his career at the Texas Department of Transportation in 1979, and retired after 30 years of service in 2009. He is currently a sales representative for Roy Bingo Supply, a position that has provided opportunities to communicate bingo fund raising efforts to many DAV Chapters and Units.



Craig's interest and involvement in DAV Auxiliary activities began long before he was eligible to join the organization. Volunteering at DAV and Auxiliary functions with event set-up, cooking, and cleaning afforded him the opportunity to participate in events with his wife and family. As time went on, the DAV and Auxiliary became a second family and sparked great interest in the mission of the organizations. When DAV Auxiliary membership eligibility was changed in 2005 to welcome male family members, Craig did not hesitate to join and was one of the first to do so!

Mr. Johniken served as a Unit Commander for three years, and was the 2011-2012 Auxiliary State Commander of the State Department of Texas. On the National level, Mr. Johniken was appointed as a member of the original strategic planning core committee formed in 2009, chairing the membership sub-committee. He also served on the Standard Operating Policies sub-committee. In 2012, he was elected to the office of National 4<sup>th</sup> Jr. Vice Commander and advanced through the chairs to his current position as National Commander.

Regarding this opportunity, Mr. Johniken stated, "I'm honored to serve in this capacity and will continue to promote awareness of the DAV Auxiliary and its mission as well as emphasize the importance of supporting caregiver initiatives and volunteerism."

Mr. and Mrs. Johniken married in 1985 and have one daughter, Ashley Clark, a son, Tim Johniken, and three grandchildren: Will, Emma, and Ashton Johniken, all members of the DAV Auxiliary. Mr. and Mrs. Johniken reside in Lufkin, TX.

## **Important Constitution and Bylaw Amendments**

There are many significant changes to the National Constitution and Bylaws that were approved at the National Convention. More information regarding these changes will soon be sent to all units and state departments. The availability of updated Constitution and Bylaw books will be announced in a future edition of the Headquarters News and other social media venues.

Some of the changes include:

- Elimination of the National History judging committee at the National Convention
- Inclusion of the applicable IRS fee(s) for new unit and state department charters
- Uniform financial reporting period for all units and state departments of <u>July 1 to June 30</u>
- Uniform filing date of the annual financial report and appropriate IRS Form 990 of September 30
- Unit and state department gross income of \$300,000 requires a review and verification by an Independent or Certified Public Accountant

We anticipate that these changes will be beneficial for Units and State Departments when determining due dates for important reports. More information to follow.

## **Quota Calculation**

Unit quotas are based on the June 30 population, less cancelled, deceased, and transferred-out members, plus any transferred-in members. Units with less than 50 members will have a quota increase of one (1) additional member. Units with 50 or more members will have a quota increase of one (1) additional member per each 25 members.

Example: Based on the June 30 total members (minus cancelled, deceased, transferred-out and plus transferred-in).

Units with 1—49 members will add 1 member Units with 50—74 members will add 2 members Units with 75—99 members will add 3 members Units with 100—124 members will add 4 members

## **Indebtedness Statement Explained**

This statement is sent to unit adjutants early in the new membership year and then again in January and April (if the unit is monetarily indebted to the national organization). A national mandate is charged annually to cover the education scholarship fund, the service support fund, and national convention expenses.

On July 1, a distribution of \$.50 is made to the unit for each life member (excluding over-80 complimentary members and those under the age of 18 paying towards a life membership). The national mandate is automatically deducted from the July 1 distribution, provided the unit has sufficient life membership to make adequate distribution to cover the national mandate. In cases where the July 1 distribution does not cover the full \$25 mandate amount, an indebtedness statement is generated.

To satisfy this balance, the unit can either submit a check to pay the amount owed or it can wait to see if enough membership is processed during following months to make adequate distribution. If the latter is decided, measures should be taken to ensure the balance is paid prior to state and national convention in order to keep your unit in good standing should you have delegates attending.

# **Reminders:**

- **Meetings**—Units must hold a minimum of four regular business meetings per year. Additional meetings are encouraged. The minimum quorum is four senior members, and one member present must be the Unit Commander or a Unit Vice Commander.
- **Bank Changes**—When a unit or state department has a change in account information, it's important to contact National Headquarters. A new direct deposit form is required, and a delay in receiving the information could mean a delay in receiving funds.
- Stories Wanted—State Departments and Units who have done something remarkable are encouraged to share their story with us. Ideas include, but are not limited to: special fund raisers, outreach programs, holiday events, meetings, and Forget-Me-Not drives. Every unit has a story! Please send your story and any pictures to <u>dava@dav.org</u>. Your article could be published in our E-Newsletter, on our social media outlets, and even in the Head-quarters News!
- VAVS Representative Certifications—State Commanders will be receiving notification requesting appointment/s for VAVS Representative/s to serve a two-year term in the VA facilities in their respective states. The position is more than a title; the appointee should be a member who is committed to fulfilling the role of the VAVS Representative. Now is a great time to start talking to your members and finding individuals to serve in this capacity.
- **Membership Listings**—Commanders, Senior Vice Commanders, and Adjutants are authorized to generate membership listings. Keep in mind these reports contain personal information (including junior members) and are to be safeguarded at all times and not freely distributed.
- Meeting Cancellation—If a Commander cannot attend a unit meeting, this would not be grounds for cancellation as the bylaws allow for the Senior Vice Commander (or Junior Vice Commander) to fill that role and conduct the meeting. In the event of inclement weather or other unforeseen circumstances that would prevent members from safely attending a meeting, these would be instance where a meeting may be canceled by the Commander with proper member notification. Meeting changes (date, time, location) must be by majority vote of the unit, not at the pleasure of the Commander.
