Legislative by Darlene Spence, National Legislative Chairman

Why so much emphasis on legislative activities? I heard this question asked several times at the DAV and DAVA National Convention in Reno, NV, and at the National Fall Conference in Lexington, KY. After returning home from Fall Conference I began to think about how I would respond to the question. Consequently, two things came to mind: the quote, "Legislation is one of the most important instruments of government in organizing society and protecting citizens," and the saying, "Educate, Agitate, Legislate."

Beginning with education, I encourage reviewing and sharing with each unit resources that may be beneficial in helping ascertain the importance of legislative action as it relates to the welfare of Veterans and their families. Additionally, it may be helpful to state reasons why voicing supportive opinions by communicating with our legislature plays an important role in the legislative process. To this end, the following information is shared.

The DAV Publication, "The Legislative Process and You," found on the DAV website, provides an understanding of how an item of legislation is created from beginning to end. The "Help DAV Advocate" section at www.dav.org outlines important bills supported by DAV and DAV Auxiliary and for which our individual support is solicited. Reviewing the bills at this site gives information that is beneficial when preparing to communicate with our elected officials.

The website www.congress.gov provides an overview of the legislative process that includes videos as well as a transcript of the overview. As we educate, we prepare our members to educate and encourage the public to become more involved in the support of legislative activities that promote the health, welfare and well-being of veterans and their families. In conjunction with the education process, please don't forget to encourage participation in the Commanders Action Network by going to www.dav.org/can.

Although we continue the education process, we are now prepared, as the saying goes to "Practice Positive Agitation" of our elective officials through communications that include but are not limited to, one-on-one communications, participation in town hall meetings, writing, calling, sending e-mails, and/or contact via selective social media. Last, but not of the least importance, communications are a reminder that we vote! These communications are to encourage our elected officials to support or even sponsor bills that are in the best interest of Veterans and their families.

Take a deep breath or maybe more than one because our activities are just beginning. As Bills are passed and become law, we must be attentive to assure that the rights of Veterans are upheld. In addition, we must identify and work in areas of support such as volunteering, providing transportation, visiting and listening, finding ways to fight homelessness, donating to the veterans' hotlines and even just offering a kind word like "thank you."

We must continue to be consistently involved in our country's legislative activities in order to assure availability of safety, appropriate health care, jobs, child care, housing, financial support and other means that support the welfare of veterans and their families. If we do not continue to voice the needs of our veterans through communications with the legislature, as is a right given to us by the first legislative process, our constitution, the past work of the Auxiliary will have been in vain.

As I have been given the honor and privilege, by which I am deeply humbled, to serve as DAV Auxiliary 2nd Junior Vice Commander and Legislative Chairman, I pledge to work to assure support of legislative activities that protect the welfare of Veterans and their families. Having returned a while back from our National Fall Conference in Kentucky, and seen the positive response to our skit on Community Service, I am more excited than ever to be the chairman for this program that, I believe, we all participate in whether we are aware of it or not. Every time one of us helps a neighbor, becomes involved in a community, school, church or local event, or any worthwhile purpose, we are participating in Community Service.

I asked the conference attendees to be more aware of their service than I was. For four years, I volunteered one day a week at the Brockton Small Claims Court as a mediator. In this instance, I was performing Community Service. Yet, the DAV Auxiliary never received any credit for the many hours I volunteered because I never reported them. Be smarter than I was and keep a record of your service for the end-of-year reports which asks for numbers in *miles, hours, donations by unit checks, value of all other donations, and cash donations from members.*

Recently, an officer in the Department of Ohio told me they submit monthly reports at their unit meetings on service. That makes preparing the end-of-year reports a simple, not a daunting, task for units. Massachusetts has always done well with their annual end-of-year reports, but not every unit participates. If every unit in the country kept good records and submitted their numbers, the Auxiliary's hours of service would probably increase dramatically.

There are six categories of Community Service: Family Services, Facility Visits, Professional and Trade Services, General Services to the Community, Recreation and Entertainment, and Special Projects and Programs.

As we head into the holidays, there are even more opportunities for Community Service: Church and Community programs to provide gifts for children and families in need and donations to food banks, among others. A few years back, a neighbor put up a notice in our condo lobby asking neighbors to buy a gift for a child, wrap it, and she'd deliver the gifts to the local fire department for their program. She loaded her SUV two times with presents.

See what you can do. Working on Community Service will make you feel good. I loved buying toys for the first time in years. Both you and the recipient will feel good about yourselves, and there will be smiles around.

Most people know the religious meaning behind Christmas Day. But, did you know that the reason it was designated a Federal Holiday has little to do with religious traditions?

It turns out that Ulysses S. Grant declared Christmas a legal holiday in 1870. The legislation also included holidays like the Fourth of July and New Year's Day. According to congressional records, the law was instigated by bankers and business men who wanted certain holidays to be formalized. The language of the bill makes it clear that Congress chose dates commonly celebrated as holidays by the American people, not for religious reasons, but because of a history of recognition and celebration on those dates.

They did not deny religious association with the date December 25. But the religious association with this day was not the reason behind proposing it is as a holiday. The law simply recognized that certain days in the year are commonly celebrated. Federal employees, overall, would greatly benefit from having these days built in as holidays. (*Rienzi, Mark L,* "Secular Reasons to Mark Religious Days", New York Times, February 17, 2013)

It is quite astonishing that a government can recognize a holiday that has religious significance to some, without mandating any one particular observance. Veterans have sacrificed to protect Americans and our way of life. During this holiday season, let's also pay tribute to the radical thinkers and leaders who created the foundations of our freedoms.
