Ask Your National Commander!

Welcome to the "Ask your National Commander" corner! Each month, we will dedicate time to answer questions that we most commonly receive. If you have a question, please send it to us at <u>dava@dav.org</u>. No question is too big or too small.

Q: Should my unit draft standing rules?

A: It is recommended that units establish standing rules to cover unique situations specific to that particular unit. Standing rules may be changed at any regular business meeting by vote of the unit members present.

Q: When should membership dues that are collected at a unit meeting be sent to national headquarters?

A: Membership dues should be sent to Auxiliary national headquarters **immediately** to allow for timely processing and membership card mailing.

Q: My unit received an Indebtedness Statement. Please explain.

A: Units are required to pay an annual \$25 national mandate which, in most cases, is deducted from the unit's July 1 membership distribution. Should there not be ample membership distribution, an indebtedness statement will be sent advising the unit as to the remaining amount owed for their national mandate.

Thinking Outside the Box with VAVS

Each year, the DAV Auxiliary VAVS Program at the Zablocki VA Medical Center hosts a large Thanksgiving meal for inpatient veterans in November. The event is catered and includes all of your favorite holiday home cooked items, including pie.

"Since COVID, the facility hasn't been able to put on this program for everyone's safety," said Patty Davis, Zablocki VAVS Representative. "However, the veterans really look forward to the holiday cheer from the DAV Auxiliary and the volunteers didn't want them to feel forgotten. That is why we started the holiday gift bag program."



This is the second year, and something they plan to do until they can get back to a normal routine. Volunteers start shopping in October once they have a list of items to include. This year, the bags were valued at over \$30 each, and included a throw blanket, puzzle, coloring book, colored pencils, notebook, pen, snack bag with drink, hygiene products, calendar, and much more. Each of the 120 bags included a card acknowledging the veteran for their service and letting them know who the bags were from. They were put together by approved volunteers of the DAV Transportation Program and Clement J. Zablocki Unit #19 (Wisconsin) on a Monday afternoon and were distributed by hospital staff.

Patty said, "We received many calls from nurses and even family members thanking us for this gift. The bags are reusable, so once the veteran is discharged, they can put their items in it for easy transport. We truly appreciate the veterans and want to be supportive during the stay at the hospital. We hope this small gesture put a smile on their face."
